



Privacy Statement

We, Emporex GmbH, Kleestr. 21 – 23, 90461 Nuremberg, Germany—hereinafter referred to as **owpbakery.com**—observe the rules of the Data Protection Act and therefore take seriously your interest in the protection of your personal information. Personal data is therefore collected by us only to the extent technically necessary. In no case shall the collected data be used, sold, or otherwise transmitted to third parties outside the company, insofar as it is not indispensable for the performance of the contract. Our company collects and automatically saves information that the browser communicates to us in our server log files.

This is:

- browser type/version
- operating system used
- referer URL (the previously visited site)
- host name of the accessing computer (IP address)
- time of the server inquiry

This data is not assigned to individual users by our employees.

This data shall not be consolidated with other data sources. Otherwise, this data shall be immediately deleted after statistical assessment.

It is very important to us as the operators of this platform that your personal data is protected and does not fall into the wrong hands. Therefore, we inform you in the following privacy statement of how we process the information you submit to **owpbakery.com**.

These data protection terms and conditions apply in addition to the Terms & Conditions (link) of **owpbakery.com**.

A) Fundamentals of processing personal data

owpbakery.com collects, processes and uses your personal data according to the valid (German) Federal Data Protection Act (BDSG) and the data protection conditions of the European Union.

owpbakery.com uses your personal data exclusively in order to facilitate you in claiming Internet services of **owpbakery.com** that require registration.



Under no circumstances will **owpbakery.com** make your data known to third parties for advertising or marketing purposes or otherwise forward your data to third parties unless **owpbakery.com** avails itself of the services of third parties for fulfilment of the Internet services requiring registration.

With the exception of some basic information, you yourself decide which personal data entered on **owpbakery.com** can be viewed publicly or only by other **owpbakery.com** members (cf. "B" of this privacy statement).

Non-members of **owpbakery.com** cannot view your personal data. If you create a company profile, only your company logo and a short description of your company are viewable. Your contact information can be viewed only after registration.

B) Required information

In order to be able to use the services of **owpbakery.com**, you must indicate certain personal information in the registration.

a) Registration as a private person:

If you register as a private person, only the following data must be made:

- user name
- email address
- password

In this case your data are not viewable for any users of **owpbakery.com**. However, you also cannot set up a personal profile.

If you would like to set up a company profile, you must register as a company.

Your password and your user name are in no case and at no time viewable for other members or third parties. **owpbakery.com** shall not transmit this information to third parties.

b) Registration as a Company

Only as a company do you have full access to all functions of **owpbakery.com**. Registration as a company and modification of your product information are free.

Your password and your user name are also viewable for other members and third parties in this case at any time.

owpbakery.com will not transmit this data to third parties.



C) Company profile after successful registration

You can design your company profile according to your own conception. For that purpose several tab pages are provided to you, on which you can provide the data of your firm, your products and your profile. Please note that this information is the most sensitive that you enter on **owpbakery.com**. In general, you can delete all entries made by you at any time.

The more complete your profile, the more attractive your products are for other users of the site.

The following entries can be made by you:

- aa) "Basic Data" tab
- Company logo
 - Company focus (required information)
 - Trade fair participation

- bb) "International Market"

In this location you can present your international activities.

Suggested language: English

You can make the following entries here:

- International company name (required entry)
- Country (required entry)
- Description of your company in English (required entry)
- Street/number
- Postal code
- City
- Phone
- Fax
- Email
- Website



cc) "Russian Market"

Here you can present your activities on the Russian market.

Suggested language: Russian

You can make the following entries here:

- Russian company name (required entry)
- Description of your company in Russian (required entry)
- International company name (required entry)
- Street/number
- Postal code
- City
- Phone
- Fax
- Email
- Website
- Further Russian offices

dd) "Products"

Here you have the option to present three selected products.

Suggested language: English and Russian

You can make the following entries for each product:

- Product name in English/Latin letters
- Product name in Russian/Cyrillic letters
- Link to your homepage
- Picture of your product
- Description of your product in English/Latin letters
- Description of your product in Russian/Cyrillic letters

ee) "Product Categories"

Here you can determine under which product categories you would like to be listed in the search (screenshots).



ff) Settings

Here you can determine the three following settings:

- "I would like to be informed of a contact inquiry"
 - ⇒ You will receive an email in your **owpbakery.com** mailbox if a user inquires after your contact information. You must then initiate contact yourself.
- "I would like to be informed when I have received an email"
 - ⇒ We inform you when a user sends you an email query in your **owpbakery.com** account.
- "I would like to subscribe to the **owpbakery.com** newsletter"
 - ⇒ You will receive our newsletter.

If you would like to receive the newsletter offered by **owpbakery.com**, we require from you a current email address as well as information that verifies that you are the owner of the indicated address or that its owner has agreed to receive this newsletter. Further information is not collected.



D) Accessibility of your profile for non-members

Your profile is also accessible for search engines (e.g., Google, Yahoo) according to the default settings of **owpbakery.com**. Thus even non-members can find your company profile via search engines. The Internet user can view the following information:

- Name of your company in English and Russian
- Your company logo
- Brief description in English and Russian

All other information you have entered in your profile can only be viewed by members of **owpbakery.com**. Thus, for example, your telephone number and your email address can only be viewed by registered users.

E) Content of linked websites

owpbakery.com in no way assumes responsibility for the content of websites that are linked to this website and that are submitted by third parties. The provider alone is liable for illegal, inaccurate or incomplete content as well as for damages arising from the use or non-use of information contained on linked sites.

F) Cookies

Our Internet sites use so-called cookies in many places. They serve to make our product more user-friendly, effective and secure. Cookies are small text files that are filed on your computer and that your browser saves. Most of the cookies used by us are so-called session cookies. They are automatically deleted after the end of your visit.

G) Log files

If you access **owpbakery.com** pages, connection data will be stored in a log file on the server log. For violations of our Terms and Conditions, **owpbakery.com** reserves the right to conduct a log file analysis to trace the violation. This is especially the case if the user acts illegally or contrary to the contract. The analysis serves both to protect **owpbakery.com** members and to secure **owpbakery.com** member data as well as **owpbakery.com** websites and **owpbakery.com** services.



H) Website activities

This website uses Google Analytics, a web analysis service of Google Inc. (Google). Google Analytics uses so-called "Cookies," text files that are stored on the computer and that facilitate analysis of website's use by you. The information on your use of the website generated by the cookie (including your IP address) is transmitted to a server of Google Inc. in the US and stored there.
